## **Description:**

Homoharringtonine is an inhibitor of protein synthesis. Blocks elongation phase of translation by binding to the 60-S ribosome subunit. Antileukemic. Inhibits SARS-CoV-2 infection in vitro (IC $_{50}$  = 2.55  $\mu$ M).

#### Stability and Solubility Advice:
