#### **Description:**

GNE 9278 is a positive allosteric modulator of NMDA receptors. Potentiates NMDA receptors containing GluN2A, 2B, 2C and 2D subunits (EC $_{50}$  values are 0.74, 3.07, 0.47 and 0.32  $\mu M$  in a Ca $^{2+}$  influx assay, respectively). Binds within the transmembrane domain and displays preference for agonist-bound NMDA receptors. Slows receptor deactivation and enhances the potency of glutamate and glycine.
