It comprises an EED (embryonic ectoderm development) based ligand, joined by a linker to a von Hippel-Lindau ligand. In B lymphoblast cell lines, UNC 6852 selectively degrades PRC2 components EED (DC₅₀ = 0.31 μ M, D_{max} = 94%), enhancer of zeste homolog 2 (EZH2, DC₅₀ = 0.67 μ M, D_{max} = 96%), and suppressor of zeste homolog 12 (SUZ12, DC₅₀ = 0.59 μ M, D_{max} = 82%).
