
RU.521 is a potent and selective cyclic GMP-AMP synthase (cGAS) inhibitor (K_d = 36.2 nM). RU.521 suppresses dsDNAactivated reporter activity (IC₅₀ = 0.11 μ M against m-cGAS, and IC₅₀ = 2.94 μ M against h-cGAS) but not 5'ppp-HP20 RNA or murine IFN- β , induced IFN- β 1-dependent gene expression. RU.521 reduces constitutive expression of type I interferon in primary macrophages from a mouse model of Aicardi-Goutières syndrome (AGS). Pretreatment of chimeric antigen receptor (CAR) redirected T cells with RU.521 increases efficiency of virus-free gene editing by improving cell viability and CAR integration in cell line.
