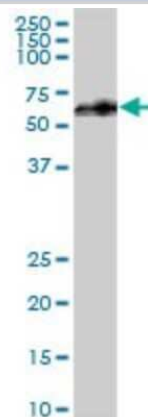

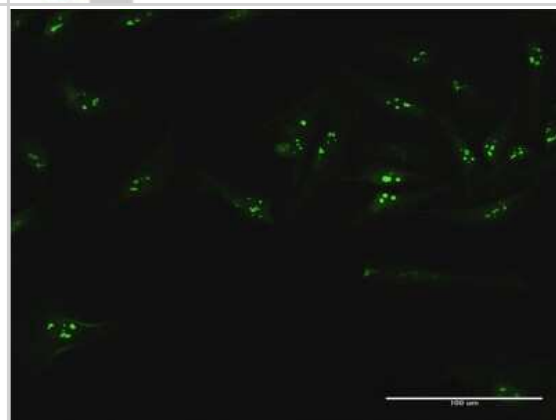

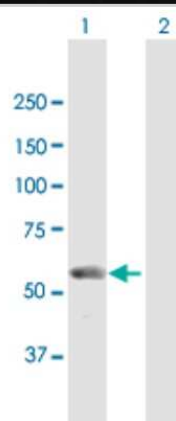
Western Blot: UTP18 Antibody [H00051096-B01P] - Analysis of WDR50 expression in human spleen.
