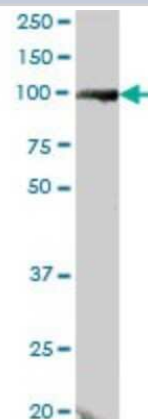

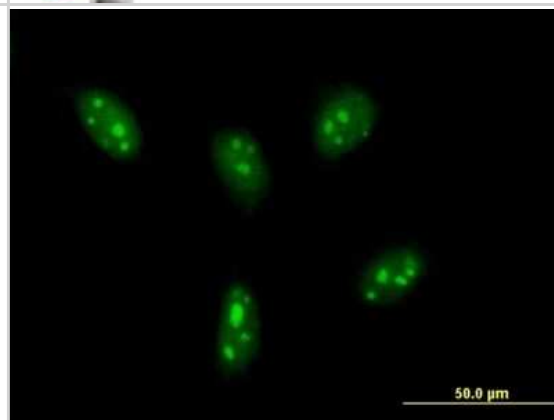

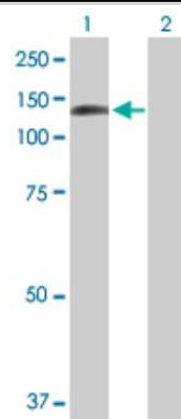
Western Blot: DDX24 Antibody [H00057062-B01P] - Analysis of DDX24 expression in human liver.
