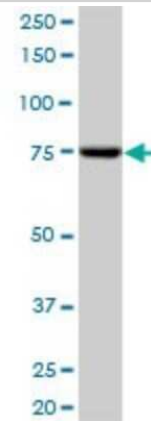

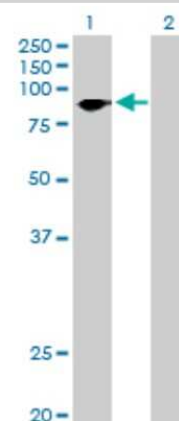
Western Blot: SCY1 like 3 Antibody [H00057147-B01P] - Analysis of SCYL3 expression in HepG2.
