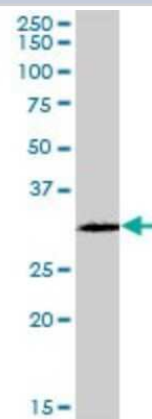

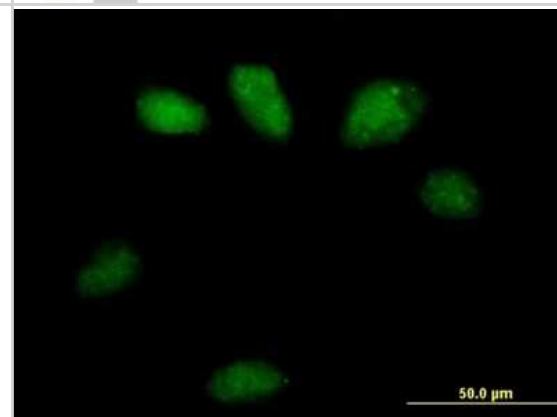

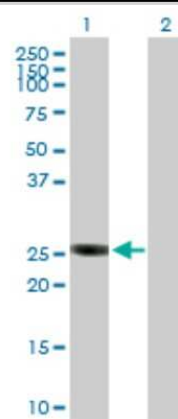
Western Blot: GSTO2 Antibody [H00119391-B01P] - Analysis of GSTO2 expression in COLO 320 HSR.
