Application Notes	WB: Preliminary experiments gave an approx. 25 kDa band in mouse eye lysates after 0.02 ug/ml antibody staining. Please note that currently we cannot find an explanation in the literature for the band we observe given the calculated size of 9.4 kDa band according to NP_034203.1. The 25 kDa band was successfully blocked by incubation with the immunizing peptide.
