Reactivity Notes	Minimum reactivity to bovine, chicken, horse, mouse, rabbit, rat and sheep.
Specificity/Sensitivity	By immunoelectrophoresis and ELISA this antibody reacts specifically with human IgG. Cross reactivity with IgA and IgM is negligible. No antibody was detected against non-immunoglobulin serum proteins. Antiserum was cross adsorbed using bovine, chicken, horse, mouse, rabbit, rat and sheep immunosorbents to remove cross reactive antibodies. Less than 1% cross reactivity to bovine, chicken, horse, mouse, rabbit, rat and sheep IgG was detected. This antibody may cross react with IgG from other species.
Immunogen	Human IgG Fc antiserum was solid phase adsorbed to ensure class specificity.
