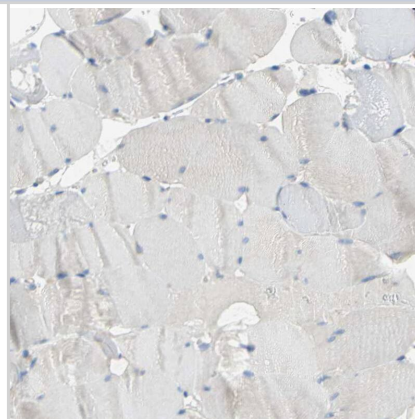

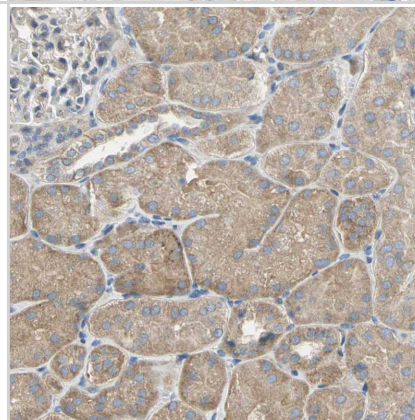

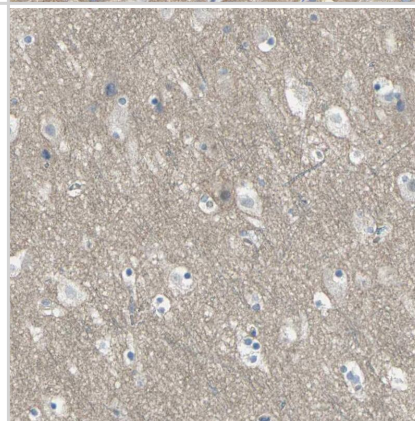
Staining of human skeletal muscle shows no positivity in myocytes as expected.



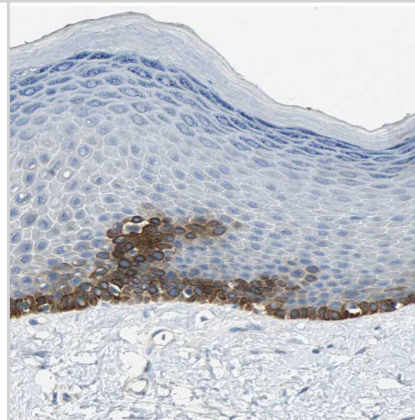
Staining of human kidney shows moderate cytoplasmic positivity in cells in tubules.
