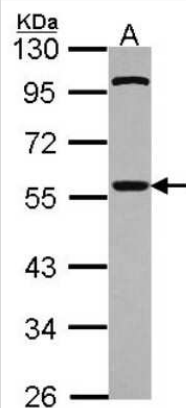

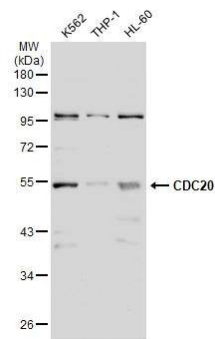

Western Blot: Cdc20 Antibody [NBP2-15825] - Sample (30 ug of whole cell lysate) A: Hela 10% SDS PAGE gel, diluted at 1:1000.



Various whole cell extracts (30 ug) were separated by 10% SDS-PAGE, and the membrane was blotted with CDC20 antibody (NBP2-15825) diluted at 1:1000. The HRP-conjugated anti-rabbit IgG antibody was used to detect the primary antibody.
