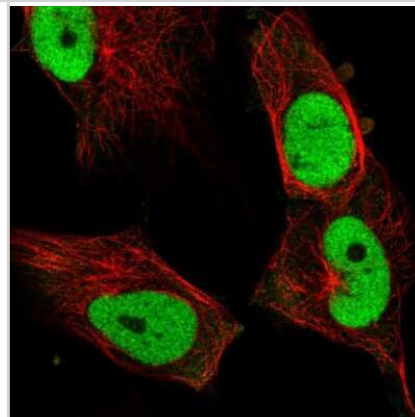

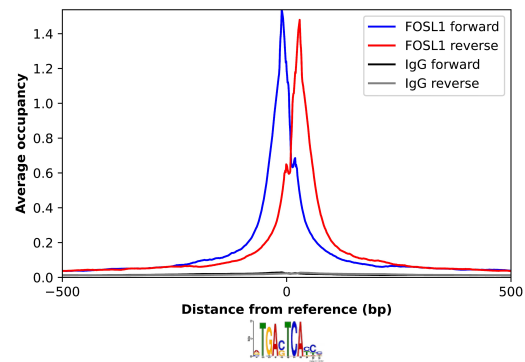

ChIP-Exo-Seq composite graph for Anti-FOSL1 (NBP2-57326) tested in K562 cells. Strand-specific reads (blue: forward, red: reverse) and IgG controls (black: forward, grey: reverse) are plotted against the distance from a composite set of reference binding sites.
