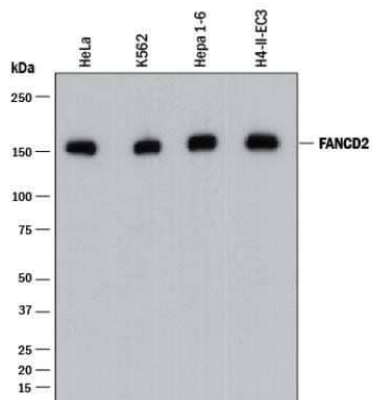

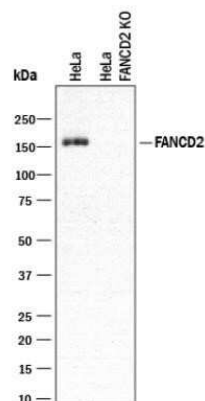

PVDF membrane was probed with 0.5 ug/mL of Rabbit Monoclonal FANCD2 Antibody (1290C) (Catalog # NBP2-61930) followed by HRP-conjugated Anti-Rabbit IgG Secondary Antibody (Catalog # HAF008). A specific band was detected for FANCD2 at approximately 150 kDa (as indicated). This experiment was conducted under reducing conditions. Image from the standard format of this antibody.

Specific band was detected for FANCD2 at approximately 150 kDa (as indicated) in the parental HeLa cell line, but is not detectable in the knockout HeLa cell line.
