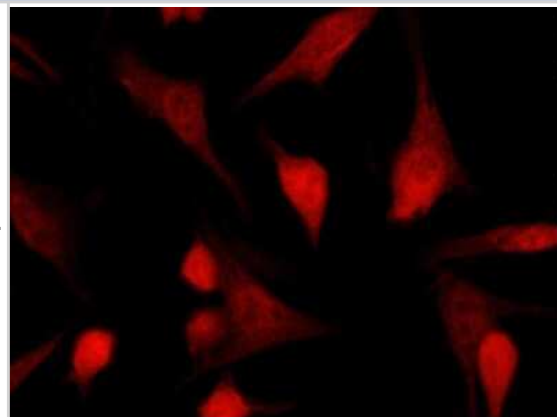

Immunocytochemistry/Immunofluorescence: TSC22/TSC22D1 Antibody (043) [NBP2-90143] - Immunofluorescence staining of Human TSC22D1 in HeLa cells. Cells were fixed with 4% PFA, permeabilized with 0.3% Triton X-100 in PBS, blocked with 10% serum, and incubated with rabbit anti-Human TSC22D1 monoclonal antibody (1:60) at 37° 1 hour. Then cells were stained with the Alexa Fluor(R) 594-conjugated Goat Anti-rabbit IgG secondary antibody (red) and counterstained with DAPI (blue). Positive staining was localized to nucleus and cytoplasm.
