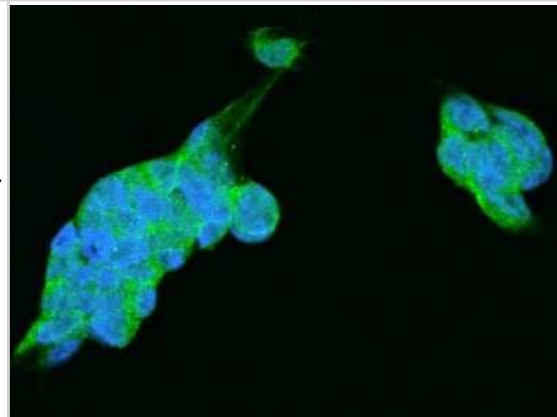

Immunocytochemistry/Immunofluorescence: Proteasome 19S S7 Antibody [NBP2-97271] - Immunofluorescence staining of Proteasome 19S S7 in HEK293 cells. Cells were fixed with 4% PFA, permeabilized with 0.1% Triton X-100 in PBS, blocked with 10% serum, and incubated with rabbit anti-Human Proteasome 19S S7 polyclonal antibody (dilution ratio 1:200) at 4C overnight. Then cells were stained with the Alexa Fluor (R)488-conjugated Goat Anti-rabbit IgG secondary antibody (green) and counterstained with DAPI (blue). Positive staining was localized to Cytoplasm.
