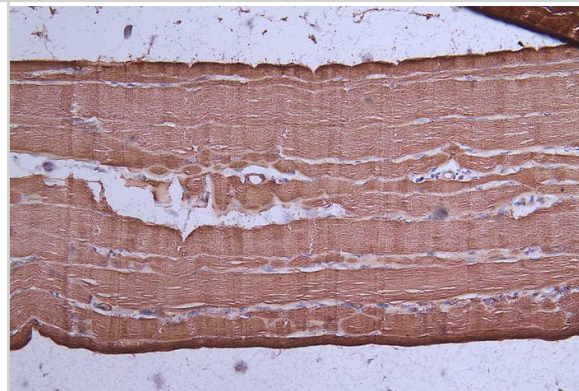

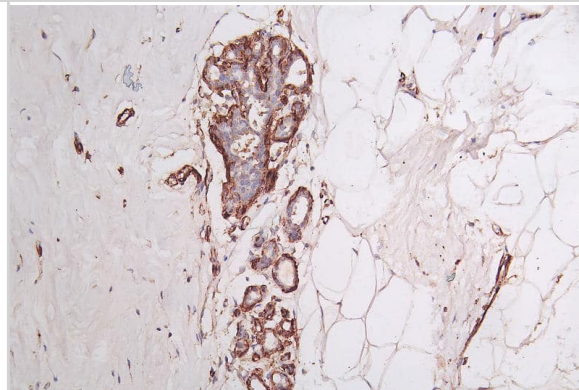

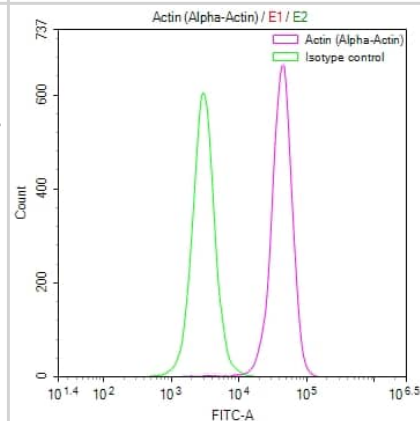
Immunohistochemistry: Actin Antibody (4C1) [NBP3-26526] - Image of Actin Antibody diluted at 1:50 and staining in paraffin-embedded human skeletal muscle tissue performed. After dewaxing and hydration, antigen retrieval was mediated by high pressure in a citrate buffer (pH 6.0). Section was blocked with 10% normal goat serum 30min at RT. Then primary antibody (1% BSA) was incubated at 4°C overnight. The primary is detected by a Goat anti-rabbit polymer IgG labeled by HRP and visualized using 0.72% DAB.



Immunohistochemistry: Actin Antibody (4C1) [NBP3-26526] - Image of Actin Antibody diluted at 1:50 and staining in paraffin-embedded human skeletal muscle tissue performed. After dewaxing and hydration, antigen retrieval was mediated by high pressure in a citrate buffer (pH 6.0). Section was blocked with 10% normal goat serum 30min at RT. Then primary antibody (1% BSA) was incubated at 4°C overnight. The primary is detected by a Goat anti-rabbit polymer IgG labeled by HRP and visualized using 0.72% DAB.



Flow Cytometry: Actin Antibody (4C1) [NBP3-26526] - Overlay Peak curve showing A549 cells stained with Actin Antibody (4C1) (red line) at 1:50. The cells were fixed in 4% formaldehyde and permeated by 0.2% Triton X-100. Then 10% normal goat serum to block non-specific protein-protein interactions followed by the antibody (1ug/1\*10^6 cells) for 45min at 4C. The secondary antibody used was FITC-conjugated Goat Anti-rabbit IgG (H+L) at 1:200 dilution for 35min at 4C. Control antibody (green line) was rabbit IgG (1ug/1\*10^6 cells) used under the same conditions. Acquisition of >10,000 events was performed.
