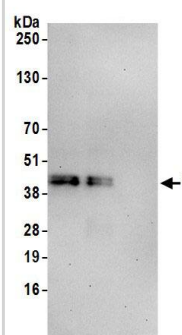

Immunoprecipitation: Mitochondrial fission regulator 1 Antibody NBP3-29157 - Detection of human MTFR1 by western blot of immunoprecipitates. Samples: Whole cell lysate (1.0 mg per IP reaction; 20% of IP loaded) from HeLa cells prepared using NETN lysis buffer. Antibodies: Affinity purified rabbit anti-MTFR1 antibody (NBP3-29157 lot 1) used for IP at 6 µg per reaction. MTFR1 was also immunoprecipitated by rabbit anti-MTFR1. For blotting immunoprecipitated MTFR1, NBP3-29157 was used at 0.4 mg/ml. Detection: Chemiluminescence with an exposure time of 30 seconds.
