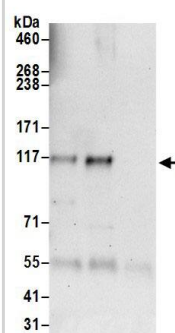

Samples: Whole cell lysate (0.5 or 1.0 mg per IP reaction; 20% of IP loaded) from HeLa cells prepared using NETN lysis buffer. Antibodies: Affinity purified rabbit anti-FGD1 antibody NBP3-29957 (lot NBP3-29957-1) used for IP at 6 µg per reaction. FGD1 was also immunoprecipitated by rabbit anti-FGD1 antibody BL20516. For blotting immunoprecipitated FGD1, NBP3-29957 was used at 1 µg/ml. Detection: Chemiluminescence with an exposure time of 30 seconds.
