Application Notes	PBMC: Add 10 ul of MAB/10 ⁶ PBMC in 100 ul PBS. Mix gently and incubate for 15 minutes at 2 to 8 C. Wash twice with PBS and analyze or fix with 0.5% v/v of paraformaldehyde in PBS and analyze. WHOLE BLOOD: Add 10 ul of MAB/100 ul of whole blood. Mix gently and incubate for 15 minutes at room temperature (20C). Lyse the whole blood. Wash once with PBS and analyze or fix with 0.5% v/v of paraformaldehyde in PBS and analyze. See instrument manufacture's instructions for Lysed Whole Blood and Immunofluorescence analysis with a flow cytometer or microscope..
