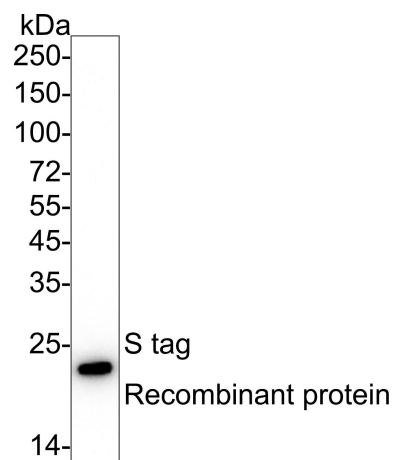

4-20% SDS-PAGE gel.

Proteins were transferred to a PVDF membrane and blocked with 5% NFDL/TBST for 1 hour at room temperature. The primary antibody (NBP3-32923) at 1/1,000 dilution was used in 5% NFDL/TBST at 4C overnight. Goat Anti-Mouse IgG - HRP Secondary Antibody at 1/50,000 dilution was used for 1 hour at room temperature.
