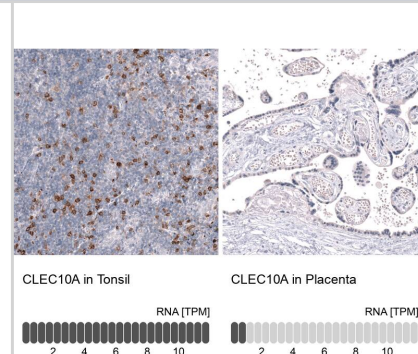

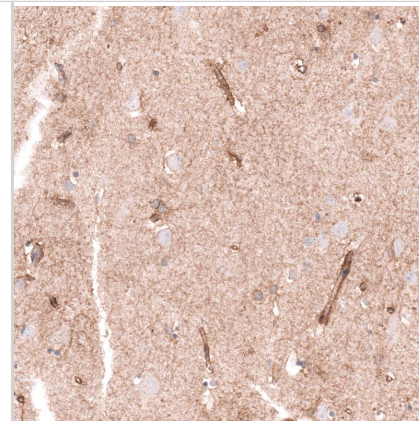

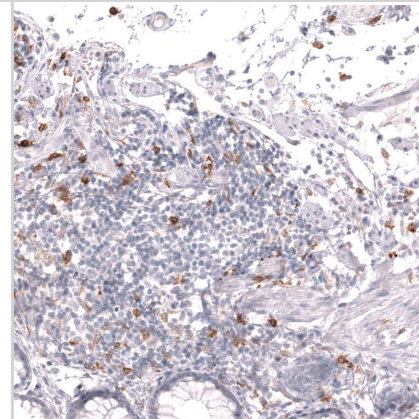

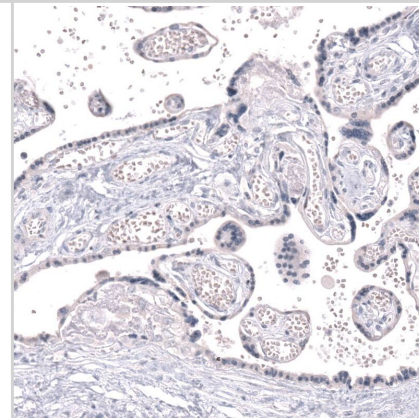
Staining of human cerebral cortex shows moderate membranous-cytoplasmic positivity in endothelial cells and neuropil.



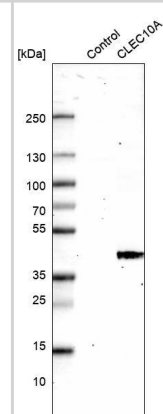
Staining of human rectum shows strong membranous-cytoplasmic positivity in lymphoid cells.



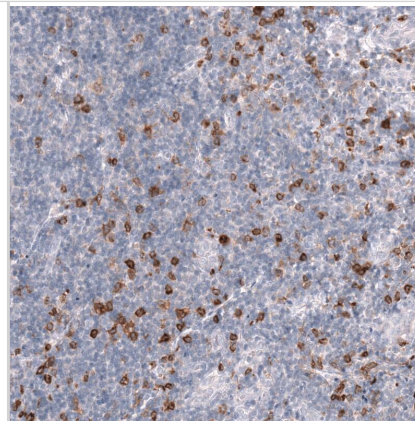
Staining of human placenta shows no positivity in trophoblastic cells as expected.
