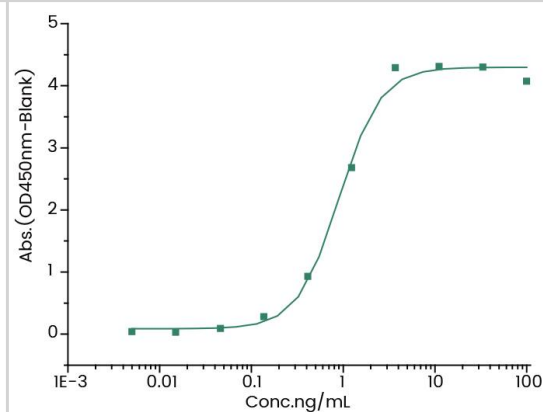

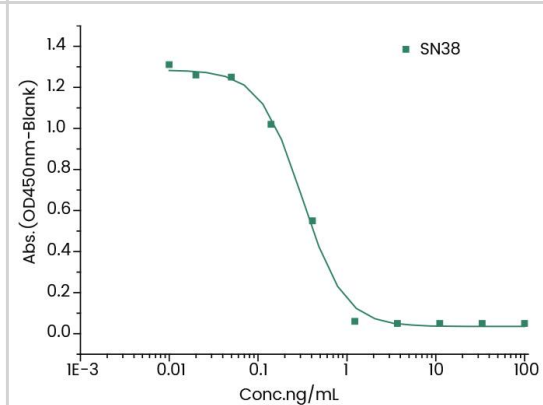

ELISA: SN 38 Antibody (7) - Azide and BSA Free [NBP3-49163] - Immobilized SN 38-OVA at 0.1 $\mu\text{g}/\text{mL}$ (100 $\mu\text{L}/\text{well}$), free SN 38 and NBP3-49163 added to the plate (total volume 50 $\mu\text{L}/\text{well}$, NBP3-49163 working concentration is 0.05 $\mu\text{g}/\text{mL}$), the binding of SN 38-OVA and NBP3-49163 were blocked by the gradient-diluted free SN 38 from 0.01 ng/mL.
